## Impact of Legacy Donors Like You

By leaving a gift in your Will, you are leaving a legacy for pets in need to feel the love and companionship that you have for your pet. **Your generous commitment** to our Greatest Shelter Needs will help thousands of animals for years to come through adoptions, emergency boarding, vet and medical care and Community Outreach Programs.



## Where Do You Start?

There are two things you need to do before you create your legacy gift and they both typically involve professional help. The **first** is to determine approximately how much you might have to give. A financial advisor can help you determine how much you will need to live in comfort. She or he can also advise on how much you might give to family and loved ones. The **second** is to consult with a lawyer and either create your first or update your current Will. This is the document that **makes your legacy come to life**.

## Which Type Of Gift Is Right For You?

There are several gift **options that may be available to you** during your estate planning. The following is a summary of commonly used forms of legacy giving. Please note: we encourage and expect you to consult a professional advisor to determine the best option for you.



#### **Preparing A Codicil**

If you have already made a Will, you can help the Brant County SPCA by adding a Codicil to your existing Will. We advise consulting with your lawyer or legal advisor before completing a Codicil. We are pleased to provide you with sample Codicil language on request. Please do not write on or amend your current Will, or it could become invalid.

### A Bequest In Your Will

There are three types of bequests available to you:

- 1) **Specific Bequest** You designate a specific dollar amount or piece of property in your Will to the Brant County Society for the Prevention of Cruelty to Animals (SPCA) (e.g., real estate, stocks/bonds, works of art) Suggested clause: "I give the sum of \$\_\_\_\_\_\_\_ (or a description of the property) to the Brant County Society for the Prevention of Cruelty to Animals (SPCA) to be used in support of its general charitable purposes."
- 2) Residual Bequest You allocate all or a portion of your estate to the Brant County Society for the Prevention of Cruelty to Animals (SPCA) that remains after all debts, taxes, expenses and other bequests are paid. Suggested clause: "I give \_\_\_\_\_\_ (%) of the rest, residue, and remainder of my estate to the Brant County Society for the Prevention of Cruelty to Animals (SPCA) to be used for its general charitable purposes."
- 3) Contingent Bequest You make a provision in your Will that your gift only takes effect if your primary intention cannot be met (e.g. if the primary beneficiary and alternate beneficiaries do not live longer than you). Suggested clause: "If neither (name of primary beneficiary) nor (name of alternate) survives me for 30 days, then I give (description of the amount of cash, percentage of residue, etc.) to the Brant County Society for the Prevention of Cruelty to Animals (SPCA) to be used for its general charitable purposes."

## Other Ways To Give

There are other ways to leave a legacy gift to the Brant County SPCA, including gifts of Life Insurance, Securities, RRSP or RRIFs, Charitable Remainder Trusts and more. Consulting your professional advisor is the best way to determine if these are **good options for you**.
